

# Magnolia Town Ordinances

This updating of the Town of Magnolia ordinances is hereby submitted following public hearings allowing input and changes at the request of the Town's residents. The herein ordinances are in compliance with current Delaware state laws, and correct older ordinances that conflicted with other small towns in the State of Delaware.

The newly written ordinances, effective July 1, 2016, and updated May 10, 2021, were drafted with the intent of preserving the small-town atmosphere, quiet and peaceful existence of the residents, safety in the best interests of the residents and their property, and maintaining the beautification of the Town of Magnolia and its historic aspects.
